The Part Final Fire Safety Approval Certificate for Educational Building of Ground Floor to 1st Floor, is issued on the basis of the inspection report of Assist. Divisional Fire Officer, Head Office, Fire & Emergency Services dated 05/11/2024 and certificate "A" (as per the provisions of said act

2006, Rules 2009 & Amendment Act- 2023) dated 25/09/2024 by the Licensed Agency M/s. Oyster Infracon Pvt. Ltd., MFS/LA/RF-464, MFS/LA-RD-434, MFS/LA-P-96 regarding the compliances of the fire prevention and life safety measures on following conditions as prescribed in the said act 2006. Rules 2009 & Amendment Act- 2023.

- 1. Under the Sub section (3) of section 3 it is the responsibility of the owner or the occupier as the case may, shall furnish to the Chief Fire Officer a certificate in a prescribed form twice in a year i.e in the month of January and July regarding maintenance of fire prevention and life safety measures in good repair and efficient condition as specified in sub section (1) of the said act & Rules 2009 section 4 (2).
- 2. Under Sub section (4) of section 3, No person shall tamper with alter remove or cause any injury or damage to any fire prevention and life safety equipment installed in any such building or part thereof or instigate any other person to do so.
- 3. The undersigned reserve the right to add/delete or amend any recommendation deemed fit during future inspection and due to up gradation of fire fighting monitoring system of this department in interest of life safety.
- 4. Any additional construction or change in use of the building or part there of shall render this certificate cancelled and invalid.
- 5. The owner or occupier shall pay annual fee at the rate of 1% of the minimum fees specified in schedule II as per section 11(1) and 14(4).
- 6. After Completion of the all interior/exterior works of above mentioned floors, it will be the responsibility of owner or occupier to inform this department & apply for renewal of final fire safety approval certificate before taking that premises in use.
- 7. The Owner/Occupier shall be obliged to renew the final fire safety approval certificate every year.
